Coalition: HUMAnE Spay & Neuter Clinic performed 6,495 surgeries in 2010. Of these surgeries approximately 95% of our clients are of little or no income but were able to be a responsible owner and have their pet altered due to our affordable prices. Our clinic is completely self-sufficient and operates in the black, with fundraising dollars applied directly to further reduced fee programs. Currently our clinic has served individuals from 32 of 39 counties in Washington State. Coalition: HUMAnE also partnered with 29 animal welfare organizations in 2010, both providing spay/neuter services for their adoptive animals, and also co-sponsoring further reduced fee programs. Our organization also co-sponsored a resource fair for low-income individuals in Pierce County that included free vaccines, microchips, pet food, and other supplies and information.
