Northwest Spay & Neuter Center's 2014 Annual Report

Northwest Spay & Neuter Center's mission is to promote and provide affordable, high-quality spay and neuter services for cats, dogs and rabbits in an effort to stop the killing of animals due to overpopulation.

Highlights for 2014 include:

- Performed 13,760 sterilizations surgeries. 8,522 were cats, 4,930 were dogs and 308 were rabbits.
- Provided 8,813 vaccines to surgery patients.
- Microchipped over 2,000 pets.
- Launched our Animal Shuttle Program, which assists in bringing animals to the clinic for surgery at no additional cost from locations as far away as Centralia and Gray's Harbor.
- Sterilized over 1,700 feral and free roaming cats at no cost to the caretaker through our "Project Catnip" package of services.
- Added a third vet and a fifth surgery day to our schedule, increasing our annual capacity by over 3,500 animals.
- Attended 12 community events to promote spay and neuter.
- Partnered with over 60 other rescue organizations.
